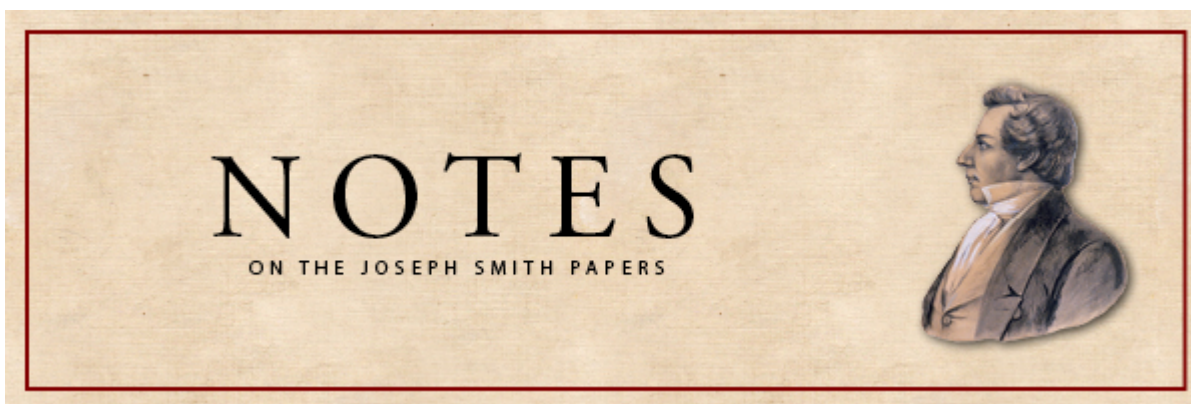

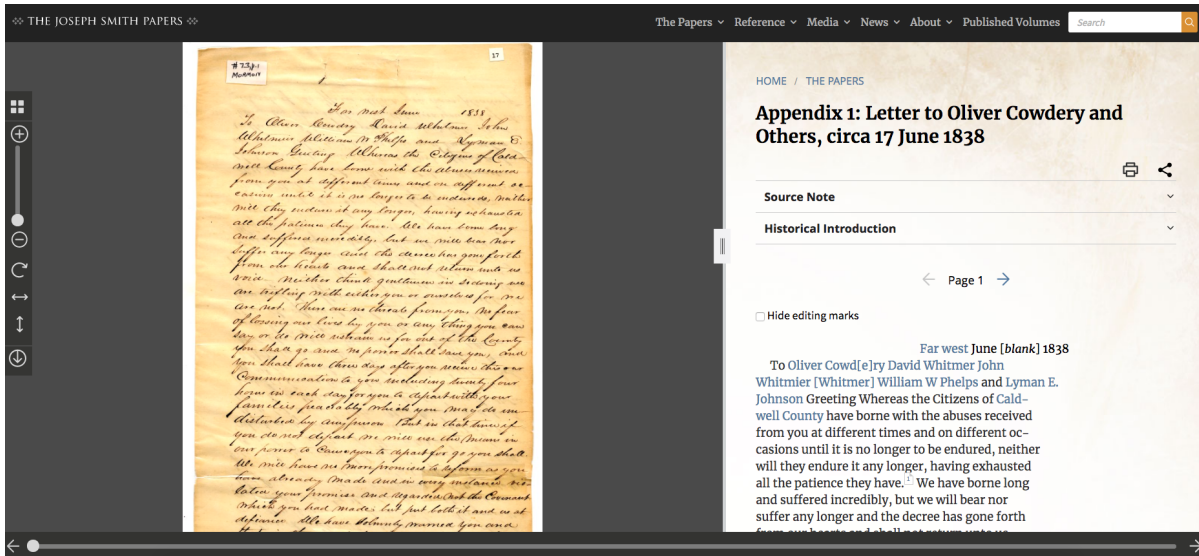

Explore New Documents on Our Website

We are pleased to announce our latest web content release. Included in this substantial publication are all documents, introductions, and annotation in [Documents, Volume 4: April 1834–September 1835](#), which was published in print in 2016. *Documents, Volume 4* includes documents pertaining to the 1834 Camp of Israel expedition (later called "Zion's Camp") that marched to Jackson County, Missouri, to redeem the Saint's land; the 1835 calling of and blessings for the Quorum of the Twelve Apostles and the Quorums of the Seventy; the construction of the House of the Lord in Kirtland, Ohio; and many other subjects from the life of Joseph Smith. Howe](#), who published *Mormonism Unveiled* in order to undermine Joseph Smith and the church, or that [John C. Bennett](#)—at one time a city and church leader in Nauvoo and later a vocal critic of Joseph—was also a prolific poultry breeder.
